 - b. S&A Committee Fee Budget Approval --- Helena & Thomas
- Helena, Thomas, and Jared gave a final presentation on all the different allocations: to summarize there will be:
- Increased hours across the board with all student positions increased wages and paid hours in the Student Leadership Organization.
- For the no change allocations: EDIC, PTK, and Emergency Fund.
- For the no request allocation changes: ASC and S&A Fee Committee.
- For the partial allocation change: WTC, Art Gallery, and Office Management.
- For the cut allocations: Front Desk Assistant but increased student wages.
- For the fully funded allocations: Info Central, Seattle Collegian, BE Learning Center, and Student Involvement.
- With any money left over the new allocations will go to the Dean of Student Development Dr. Kumbi, to watch over the funds as they get deposited into new student positions and for student engagement. They will also move those allocations to CAB for more money for student events and student clubs.
- We will wait until next year to add new student jobs for a fresher start.
- Nina and Fatimah approved the vote for the new S&A budget, and the vote was unanimously approved.

- PTK now understands they need to reshape and reform as a more organized organization.
- They want to make it more accessible for more students both apart of PTK and
- And have better communication with members of other organizations in Student Leadership instead of being an independent mind.
- a. Bylaw conversation with Dr. Kunbi, Katie, and Jared:
- Within the bylaws, there are agendas we can and cannot change for the next year.
- Able to make small tutorial changes but not substantial changes as of now.
- Tried to make decisions based on how much they affect everyone rather than certain specific organizations.
- The bylaws as it stands right now are changing to make more sense in the
 positions themselves and the hiring of these positions, we would not want to
 create more problems for roles having new and multiple roles.
- The major topics she addressed with ASC were; conflict interests by taking both an ASC executive and a club president position and clarifying an issue about an Executive can/cannot take a club president position?
- The problems that resurge are these: First there is a time constraint problem and having different commitment times makes it a struggle.

- The number of positions in Student Leadership and the percentage of people that can participate in leadership roles in clubs is already at an exceptionally fine line there will be too much concentration of power for one person, which should be as open as possible.
- Academics always come first and will be a struggle with all the positions you have to juggle.
