ASSOCIATED STUDENT COUNCIL Minutes

A. CALL TO ORDER (1 min)

Chairperson: Jinyang Xia, *Executive of Finance* The meeting was called to order at 3:10PM

B. <u>**ROLL CALL**</u> (1 min)

Everybody was present, Gaza was present as the WTC Representative.

C. INTRODUCTION OF GUESTS (1 min)

Miguel from the Seattle Collegian is present as a guest.

D. LAND USE ACKNOWLEDGEMENT (1 min)

"I acknowledge the land on which we stand today as the traditional home of the Coast Salish people, the traditional home of all tribes and bands within the Duwamish, Suquamish, Tulalip, and Muckleshoot nations. G. OLD BUSINESS (1 min)

Ronnie moved to approve the minutes and Danya seconded it, the motion passed.

H. NEW BUSINESS (25 min)

1. Seattle Collegian Overview & Update- Seattle Collegian Representative, *Seattle Collegian* (15 min)

They are currently running on a skeleton crew, their staff is around 7 people who work regularly, not including guest writers. Their goal is to publish one article a day and they are still looking for a graphic designer and content designer.

Nikki asked for clarification about student employees at the newspaper, Miguel said they are always welcoming to student writers. They prefer editors to have experience, but writers of all skill levels are welcome, no prior experience is required.

Jinyang asks what Miguels favorite article on the Collegian is so far, his favorite article is an article about transparency about school budgeting.

Ronnie requested the Seattle Collegian to send someone who can join the Communications Committee.

 Student Union Building Visit Update – Ronnie Kuan, Executive of Administration (5 min) The ASC visited Shoreline and Green River college student buildings for insight into the Student Union Building.

They were able to speak with the Dean of Student Development at the Green River Campus and the dean may attend the next ASC meeting.

Danya mentioned that visiting Shoreline gave more perspective about what a modern student union building looks like. Tamara appreciates how they advertise student events around the building via posters. Shoreline used sandwich boards to advertise as well, and the EDIC office is conveniently located in the student union building.

Jinyang noticed that the Shoreline campus is very spread out, so the Student Union building is a good place for students to meet away from classes.

Ricardo gave a note about student gathering spaces compared to classroom capacity and SCC is currently at a deficit communal-wise. He was surprised by how many students at Green River were engaged in the space.

Miguel asked about an update about the bookstore's new location and something about the cafeteria. Bradley Lane mentioned hiring a reliable vendor for the school cafeteria.

Jinyang mentioned that upcoming student leaders and faculty will be responsible for these topics given time and resources. He mentioned the grab and go food station in Shoreline. The goal this year is jut o get approval from the student building. Voting will be next quarter. He mentioned the Student Union Building is an open meeting and people are free to attend and ask questions.

Gaza introduced themselves, as they will be the new WTC representative in place of Hunter. All voted in favor, and they were ratified.

Gaza brought up a question about S&A funding for WTC and Ricardo recommends them to confirm their total budget. Gaza understands they had about 12k and says they are shocked about the reduction to 4k. WTC is an expensive program, and she has spent over 2k on just materials, not including books, so they ask if the budget is still open to appeal.

Jinyang clarifies that the appeal deadline has passed. Ricardo mentions the WTC has not used the budget much in the past, which may have contributed to the decision. From now on, the S&A committee will request a report from director that breaks down how costs are being used
