1. Introduction of Cultural Representatives– Jared Rogers, Co-Leader of Queer Trans Cooperative (20 min)

Jared presented a proposal on behalf of the Queer Trans Cooperative to uphold diversity through Diversity Student Organizations. The proposal entailed:

- Creating a position on the student council
- Diversity Student organization to uphold the voice of the community
- Must be representative of a group, community, or identity
- Need to meet two requirements- must be active for at least two quarters excluding summer unless they opt to. The second requirement is to have at least 20 unique individuals in the organization.
- They have voting power in the ASC meeting
- Once they meet requirements- they need to inform and wait for confirmation from the ASC so that they will be input into the ASC agenda
- Having a seat in ASC will not be a paid position- their purpose is to be able to give opinions and inputs as well as proposals
- Would not be a paid position, volunteer based

Upon further discussion, the meeting was extended, and the ASC did not vote on the proposal.

The proposal will be revisited in a future meeting.
