 Springboard8 Program Presentation – Eustace Mazila, Manager of Springboard 8

Eustace gave an overview of Springboard 8. This program helps Black male students complete their degrees with support from Slalom, a local company. They offer Financial Aid, 1-on-1 sessions with coaches. He also announced applications for cohort #3 are now closed and asked ASC for support with spreading awareness about the program. Suggestions were given like inviting participants to attend ASC meetings, club involvement, and many more.

2. **Review and Approve WACTCSA 2023 Legislative Agenda** – Danya Vangas Almejo, *Executive of Legislative*

Danya gave an overview of the WACTCSA goals: Textbook Affordability,
